Dear Parents:

Summer 2017

The Glorietta Piano and Guitar Program continues in the summer months! During the summertime these lessons are given in your home. The summer session begins mid-June and is open to both new and continuing students. **The schedule will be arranged around your vacations and your child's summer activities.** We also offer in-home lessons on violin.

SUMMER MUSIC TUITION: Summer music lessons are paid for three at a time, but **there is no charge for any lessons that are canceled with at least 24-hour notice to your child's music teacher.** The rate per lesson remains the same as that for in-home lessons during the school year (rounded off): \$42 per 30-minute lesson and \$63 per 45-minute lesson. If any supplies are purchased for your child, you will be billed for this separately. If you wish to pay by credit or debit card for the summer lessons, please check the corresponding box on the registration form.

We sincerely hope that many of our present students will continue lessons during the summer so as not to lose skills gained during the school year. Summer is also a good time for children to **begin** lessons--without the pressure of homework competing with practice time! We would like to have all registration forms as soon as possible so we can start to work on scheduling a time for your child. Thank you!

INSTRUMENTAL MUSIC LESSON REGISTRATION AND AGREEMENT

I, the undersigned, am the parent of a child who wishes to enroll in the Instrumental Music Program (“Program”) offered through Instrumental Music for Children, Inc. (“IMC”). This document is an agreement (“Agreement”) between myself and IMC.

IMC agrees to provide independent contractor/teachers who will provide instrumental music lessons to my child. I understand that IMC is agreeing only to provide qualified music teachers who will provide music lessons to my child as stated below. I agree to hold IMC, together with its agents, managers, and employees, harmless from any claim which does not arise from its duty to provide independent contractor/teachers who are qualified to give instrumental music lessons under this Agreement.

I understand that a lesson that needs to be missed must be canceled by notification of the music teacher at least 24 hours in advance in order to avoid a charge for the lesson.

Please make checks payable to IMC (this stands for Instrumental Music for Children), and mail this form along with your payment for the **first 3 lessons**, (\$126 for 30-minute lessons, \$189 for 45-minute lessons) to IMC, P.O. Box 1934, Benicia, CA 94510. (Please do not combine a summer lesson payment and a school-year lesson payment on the same check. Thank you!) If you have indicated you would like to pay by credit or debit card there is no need to include a check with the registration form.
